

## CONTRIBUTOR AGREEMENT

This agreement is by and between the Koga Institute (KI) and the Contributor (CR) accessing this web page. By completing the form displayed below, which creates a user account on kogainstitute.com (website), and by uploading a product to website, the CR hereby agrees to the following:

KI has the discretion to determine whether or not CR products meet the criteria for publication on the website and or other specified reproduction and shall put each product through an approval process as determined by KI.

This Agreement will come into effect from the date of acceptance by KI and will continue in full force and effect until terminated by either party, with or without cause. Acceptance and/or Termination of product agreement shall be in the form of written notice via email.
